WELCOME TO WEISS LAKE!

- BOAT CHECK WILL BEGIN AT 3:00 AM!
- BOATS CHECKING IN BY WATER WILL COME TO THE DOCK WITH FLASHING RED LIGHTS.
- SAFETY FIRST! ANYTIME THE BIG MOTOR IS RUNNING, YOU MUST BE WEARING A COAST GUARD RATED PFD (EVEN IN PRACTICE). PFD REQUIRED BELOW DAM.
- PLEASE FOLLOW ALL POSTED WATER CONTROL SIGNS AND BOUYS. TICKET DURING TOURNAMENT = DQ.
- BLAST OFF AT 5:30AM/FIRST FLIGHT DUE IN AT 2:30PM. THIS IS A TRAILERED WEIGH-IN.

WEISS LAKE

- WHEN YOU ARRIVE AT BOAT CHECK ON FRIDAY AND SATURDAY MORNING, THE TEAM MEMBER IN THE VEHICLE'S DRIVER SEAT NEEDS TO HAVE THE TEXT MESSAGE WITH THEIR TEAM'S BOAT NUMBER OPEN ON THEIR PHONE.
- THE VEHICLE'S DRIVER WILL BE GIVEN A KEY FOB AT BOAT CHECK. THE KEY FOB HAS THE TEAM'S BOAT NUMBER.
- DO NOT LOSE YOUR KEY FOB!!! YOU MUST RETURN THE KEY FOB AT WEIGH-IN IN ORDER TO WEIGH YOUR TEAM'S FISH.

OFF LIMITS AND NO WAKE

- OFF LIMITS WILL BE 50 YARDS FROM END OF LONG DOCK AND 50 YARDS FROM RAMP.
- EVERYTHING IN FRONT OF RAMP AND DOCKS WILL BE INCLUDED IN OFF LIMITS AREA.
- ABT WILL OBSERVE AND ENFORCE A NO WAKE ZONE 100 YARDS ABOVE THE FLOATING DOCKS ON THE WEST SIDE OF THE LAKE AND 100 YARDS BELOW THE RAMP.

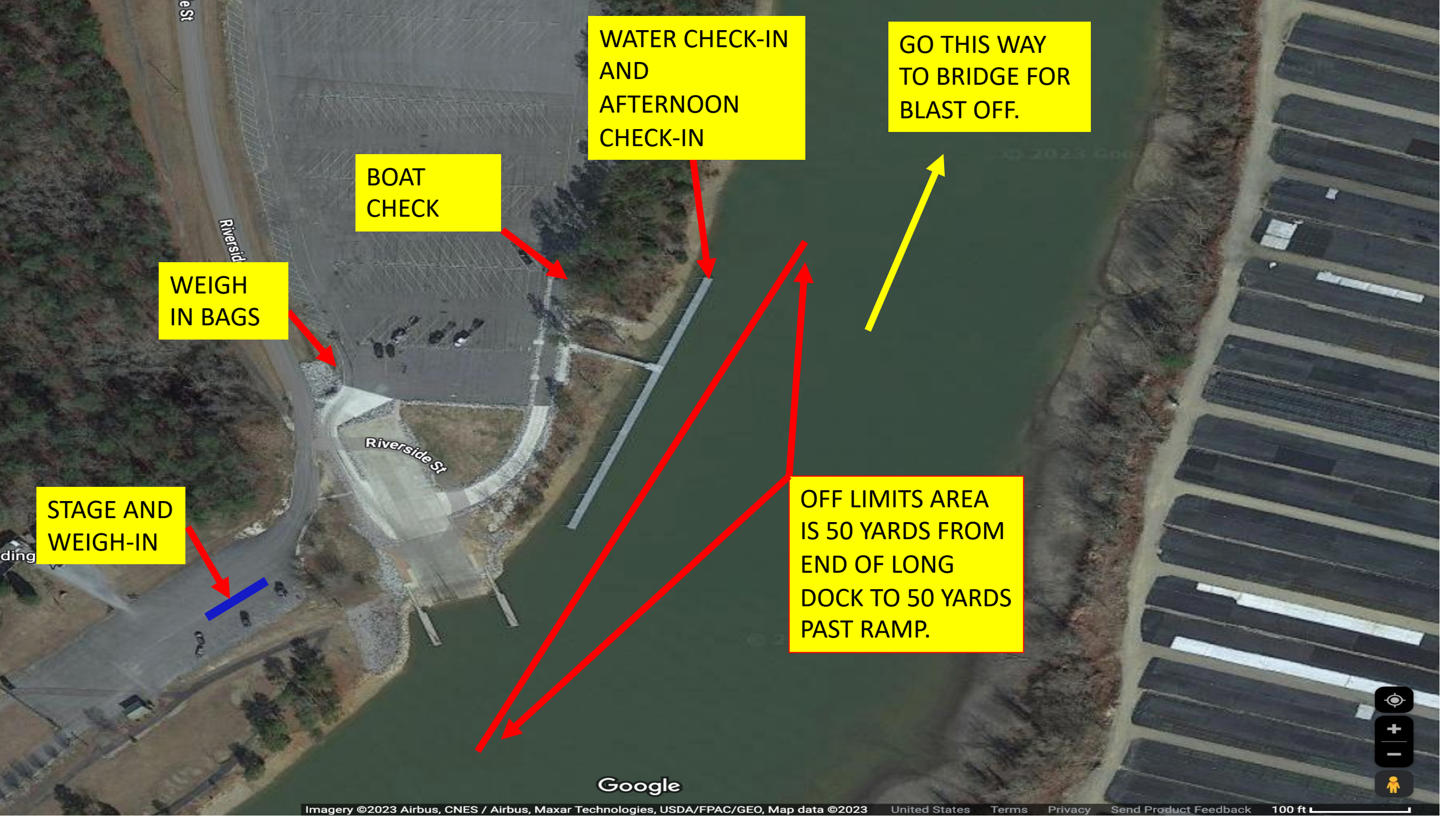
